California elections already have proven safeguards to verify voters and protect our ballots.

If Prop 39 passes, it would make voting harder for citizens, expose Californians' private information to identity theft and abuse, and fuel Trump's anti-California revenge tour.

What is Prop 39?

Prop 39 is a proposed Constitutional Amendment, placed on the November 2026 California ballot by MAGA Republicans and billionaires. Make no mistake: Prop 39 will make voting harder, riskier, and more expensive for Californians *because that's what it was designed to do*. MAGA cronies and tech billionaires are coming together again to target California voters because they know our vote is our voice and it's the only thing keeping Trump from seizing more authoritarian power.

Californians won't fall for it.



Prop 39 would hurt CALIFORNIA voters:

- ✗ **Exposes Voters to Identity Theft:** putting ID numbers on mailed election materials creates a paper trail that can be stolen or mishandled.
- ✗ **Makes Voting Harder and Increases Rejection of Valid Ballots:** adding new barriers for mail voters means simple errors - like blank fields, wrong digits, or confusion about which ID to use - could lead to rejected ballots.
- ✗ **Creates Delays at the Polls:** adding repetitive ID checks is not only unnecessary - it slows voter check-in, creating longer lines and delays for people who are already juggling work, childcare, and eldercare.
- ✗ **Targets Voters Facing Barriers:** seniors, students, low-income voters, those with disabilities, voters of color, and those who have changed their names, including because of marriage/divorce or gender transition, will be disproportionately blocked from voting.
- ✗ **Slows Ballot Counting:** more administrative workload for election workers means a slower vote count and gives Trump and his lackeys more time and fuel to spread conspiracy theories.

Prop 39 would dramatically change how we vote:



Eligible voters may have their **mail ballots rejected** unless they designate a specific personal identifying number – like a Social Security Number or license number – for mail voting and **perfectly match the last 4 digits of that number on their ballot envelope each election**. Elections officials would not be required to notify mail voters who make mistakes or forget to write this number on their envelope.



Citizens would be **prohibited from voting at the polls** unless they present a government-issued ID card. The measure is unclear on which kinds of ID would be accepted.



Every year, election workers would be required to **run “citizenship verification” checks on existing voters**. It’s unclear which databases would be used to cross reference these checks or who else would have access to them.



Prop 39 would waste hundreds of millions in taxpayer money on:



Effectively **re-registering over 26 million existing voters** to allow them to “designate” a personal ID number to be used for mail ballot return.



Creating **massive changes to complex voter registration systems** and increasing ongoing staff costs for elections.



Defending against **frivolous lawsuits** from voter-suppression groups pushing conspiracy theories.
